There have been many exciting expansions to MCHP's research capacity with funding successes received from both granting agencies and private funders. They include:

 The Lupina Foundation funding of the project titled Maintaining and enhancing tools for administrative databases under the leadership of Leslie Roos and Lisa Lix.

The Manitoba Health Research Council is providing funding to:

#### **Deliverables Completed**

Sex Differences in Health Status, Health Care Use, Outcomes and Quality of Care: A Population-Based Study for Manitoba's Regional Health Authorities

Released November 24, 2005, this report reveals how males and females in Manitoba compare on a variety of key health indicators. Descriptive results are provided for RHAs and districts, as well as by age and neighbourhood income level. The indicators cover many areas, including mortality, chronic diseases, use of physicians, hospitals, home care, personal care homes, and pharmaceuticals. The report also features chapters addressing sex differences in cardiac care, outcomes of hospital care, and indicators of the quality of physician care. This is the third report involving *The Need To Know* Team (funded by CIHR) Team.

#### **Deliverables in Progress**

#### Patient Safety Issues: A Systems-Wide Approach for Manitoba

This project is framing quality of care, not as a medical error issue but as an issue of patient safety. Indicators of patient safety are being estimated for the province, as well as across hospitals and regions. Indicators of compromised patient safety are based on the work of organizations like the Agency for Healthcare Research and Quality and CIHI, as well as the advice of the Working Group. Examples of potential indicators in the study are: death in low-mortality surgical admissions, death in low-mortality medical admissions, post-operative wound dehiscence, and obstetrical trauma.

#### Profiling the Care Delivered by Primary Care Practices: A Baseline Measure

The focus of this research is on developing indicators appropriate for monitoring the delivery of primary care in the province, at the level of the primary care physician's practice, not the individual patient. The purposes of the study are to develop indicators of primary care delivery, describe current patterns of primary care physician services delivery, and offer insights regarding variability in the scope, breadth, and quality of services delivered by primary care physicians. This is a methodological study, building on earlier work by MCHP and breaking new ground in developing indicators of primary care with some preliminary analyses to demonstrate how the indicators could be used.

#### Defining & Validating Chronic Diseases: An Administrative Data Approach

This deliverable establishes case definitions of various chronic diseases, using administrative data and examining what are the appropriate time spans (retrospective data) required for the most valid case definitions. There are some chronic diseases for which there are several case definitions, such as diabetes, so work would be needed to establish the most valid yet practical measure. There are others, such as arthritis, where very little work has been done to date. Valid and reliable case definitions will be useful for Manitoba Health and the RHAs to monitor the population's health status and to contribute to healthcare management reports.

#### Using Administrative Data to Develop Indicators of Quality Care in Personal Care Homes

MCHP reviewed the quality of care in PCHs in 1993. With the change in how nursing homes are used, with more individuals entering at older ages for shorter stays, it is timely to revisit the issue of quality in PCHs. A recent MCHP report identified wide variation in the percentages of PCH residents transferred to hospitals near the end of life (Menec et al.), which means that in some PCHs, individuals are much less likely to die "at home", and suggests possible differences in quality of care. What set of indicators of quality of care in a PCH should be used, from an administrative database point of view? While there are no benchmarks for the majority of indicators, the variation between PCHs, and the

possible reasons for this variation, will be of interest to Manitoba Health, RHAs, individual PCHs and care providers.

# Developing a Needs-Based/Population-Based Funding Methodology for Manitoba's Regional Health Authorities

This project considers alternative approaches to funding that might reasonably be expected to meet the overall healthcare needs of Manitobans, while acknowledging the practical, policy and equity issues that are involved in funding health services. Since RHAs were established in 1997, their funding has been based on historical experience, and regional plans and budgets. Recently, Manitoba Health has provided RHAs with 5-year budget targets. If the healthcare needs of the population of each RHA were the same, a needs-based funding approach would simply take the total available resources and distribute them according to the size of the population in the RHAs (a 'per capita' funding approach). However, there are important considerations that must be taken into account. These include age and sex, the difference in need for health services across regions, and specialized care received outside a person's region of residence. This research will not determine the 'right' amount of funding to meet healthcare needs, but rather will consider the best way to distribute available funds to improve the overall health of the Manitoba population.

#### Assessing Surgical Waiting Times Using Administrative Data and Patient Registries

MCHP has looked at elective surgery waiting times for a number of procedures from 1992/93 to 1998/99. This method of measuring waiting times, i.e., using a pre-operative visit to the surgeon to flag the beginning of the wait, has been validated through chart review for elective general surgery procedures. This deliverable will update these analyses by adding five more years of data. In addition, waiting time registry data, for cardiac, hip/knee replacement and cataract surgery, are being explored to provide further validation for administrative data methods for estimating wait times, and to explore additional patient characteristics that might explain the variation in wait times. This study will explore such issues as: Have waiting times changes since the 1998/99 study? Can waiting list registry data be used to validate the use of administrative data to estimate waiting times? Is there variation in outcomes associated with different wait times? Do wait times vary by age, sex, socioeconomic status, region of residence?

#### Analysing the Urgent Care and Emergency Room (ER) Datasets of Winnipeg

When significant new databases are incorporated into the Repository, it is necessary to document the fields available, what they mean, and perform checks on the the completeness, reliability and validity of the new data. That is the task of this deliverable with respect to ER and Urgent Care data for Winnipeg hospitals. Preliminary analyses will also be conducted to describe the characteristics of ER users, with special interest on frequent users of ER/Urgent Care services. The findings from this report will assist health system planners to understand the types of demands on emergency room services, how patterns of ER utilization have changed over time, and why patients visit ER.

# The Costs of Hospital Care: Updating of the Manitoba Management Information System (MIS) Dataset

The Manitoba Management Information System (MIS) contains data about the management of health services in the province. Financial and statistical data included in MIS are important indicators of performance and can be used to provide micro- and macro-level costing of health services. Updated cost indicators would form the basis of population-level cost-based studies where hospital care is involved. This project will develop an updated "cost per weighted case" for inpatient and day procedures in Manitoba hospitals. It will also produce an updated "cost per hospital stay" for various types of cases (e.g., hip replacement, pneumonia), and average costs per weighted case for different hospital types in Manitoba (e.g., Winnipeg community hospitals, large rural hospitals).

#### Development of Composite Measures/Indices of Health and Health System Performance

While hundreds of indicators exist that measure specific aspects of health, use of health services, and health system performance, there is a lack of high quality composite measures in key strategic areas. For example, there is no single measure that tells us what is happening overall for "chronic diseases" or "quality of care" within the province. Indicators at the population/system-wide level would be useful for strategic planning and reporting. This project will, through a literature review, expert consultation and previous experience, construct composite indicators in three or four areas of health and healthcare. Indicators will be reported for Manitoba's regions over time

#### Dynamic Physician Resource Projection Model

This project will provide scenarios that incorporate different assumptions that have an impact on the demand for physicians in four key areas identified by Manitoba Health: Family Medicine, Paediatrics, General Surgery and Orthopaedic Surgery. Models will be developed that will project the service needs of the population given the changes in age and sex distribution predicted by the Manitoba Bureau of Statistics; and models that will project the required changes in the workforce to meet the expected demands of the changes in population characteristics given the physician characteristics, e.g., age, sex, average workloads, etc. MCHP will use historical data housed in the Population Health Research Data Repository to develop and test these models. The output of the project will not be a definitive answer to the question: "How many physicians are needed in Manitoba?" but will provide tools that can be used by Manitoba Health and potentially other organizations, such as the University of Manitoba's Faculty of Medicine to project supply and demand under different conditions

#### Evaluation of the BabyFirst Program (Healthy Child Manitoba)

Manitoba's BabyFirst program screens newborns for biological social and demographic risk factors and provides community-based supports (e.g. home visits) to families in the program up to the time the target child is three years old. An important program goal is to ensure children's physical health and safety. The evaluation will focus on outcomes for the target children which include health (mortality rate, hospitalizations, emergency room visits, physician visits and positive outcomes), history of protection and support (foster care or protective services). Selected outcomes for mothers of target children (age at birth of first child, depression diagnoses) will be assessed to determine their relationship to child outcomes. Family factors such as residential mobility, marital status, number of children, and spacing between children will also be explored.

#### **Endowed Chair in Child Health**

The Endowed Chair in Child Health was awarded by the Department of Energy, Science and Technology, Province of Manitoba and will be available in January 2008. It will supp9ort a long-term senior researcher who will coordinate and lead child health research at MCHP.

#### **Evelyn Shapiro Health Services Research Award**

This fund was established to provide an annual award to a graduate student in the Faculty of Graduate Studies, specifically in the Faculty of Medicine, who is conducting research which will use the Population Health Research Data Repository.

This award of \$750,000 was given to MCHP for the period January 2002 through January 2008, for Research in Children's Health. This gift provides financial support for senior investigators, clinicians, visiting scholars, and graduate fellows to conduct research in the broader determinants of children's health.

#### **KNOWLEDGE TRANSFER**

Each year, one of the six MCHP deliverables is not a report, but instead it encompasses all the activities surrounding research knowledge transfer. MCHP researchers and staff carry out more of these activities than is common among most academic units. The following represent the many areas of research knowledge transfer done over the past year.

#### **BRIEFINGS**

Prior to the release of a deliverable, Manitoba Health senior executive and managers, including the Deputy Minister and Minister, receive briefings which highlight the outcomes and recommendations of the particular report.

Stakeholder groups are also briefed prior to relevant releases. These groups include: Departments of Education, Family Services & Housing, and Health; Manitoba Medical Association; College of Physicians and Surgeons of Manitoba; rural Regional Health Authorities; Manitoba Patient Safety Institute; Winnipeg Regional Health Authority. # CPHI Project: Inequalities in Child Health: Assessing the Role of Family, Community, Education and Health Care

This project began in 2003 and is headed by MCHP senior researcher Marni Brownell. In June 2004 the first report on some of the work done on this project was released. *How Do Educational Outcomes Vary With Socioeconomic Status? Key Findings from the Manitoba Child Health Atlas 2004* provides an overview of key findings from the Child Health Atlas itself. The full Child Health Atlas Report is web-based only and was launched in July 2004. This site provides descriptive, population-based analyses of the health and educational outcomes of Manitoba children, at the level of health regions and sub-regions. (see <a href="http://www.umanitoba.ca/centres/mchp/reports/child\_inequalities/index.shtml">http://www.umanitoba.ca/centres/mchp/reports/child\_inequalities/index.shtml</a>)

Knowledge translation efforts began long before these finished products, and interactions with provincial ministries and other organizations helped shape the reports and knowledge translation activities.

Several months prior to publication, we began presenting preliminary findings to stakeholders including ministers, deputy ministers and senior policy analysts in the Departments of Education, Family Services, Healthy Living, and Healthy Child Manitoba, as well as to policy makers within school divisions. Each presentation yielded valuable feedback, shaping subsequent presentations, making results more relevant and accessible to stakeholders. Numerous presentations were also made after report release.

The long-term impact of these knowledge translation activities is yet to be determined; short-term results include the Public Schools Finance Board considering our results with respect to the public schools funding formula, and the Social Planning Council of Winnipeg striking four sub-groups to develop responses to our results, including using the findings as the basis for a major project proposal submitted to the Social Development Council.

## **RBC Foundation Child Health Research**

Research on children's health continues at MCHP. The gift from the RBC Foundation has helped MCHP researchers establish ties with outstanding groups to ensure that MCHP takes full advantage of the unique data resources in the Repository. Recent collaborations with researchers in the United States and Australia have created new unique opportunities for work with data resources in our world-class Manitoba Population Health Research Data Repository. The following are some of the activities undertaken in the past year:

Dr. Irene Yen joined the Manitoba Centre for Health Policy as an RBC Financial Group Child Health Research Fellow in August, 2005. In collaboration with MCHP Senior Researchers Drs. Noralou Roos and Marni Brownell, Dr. Yen is researching children's health and educational outcomes are by length of time on income assistance. Dr. Yen is an epidemiologist with particular research interests in neighbourhood environment, housing, and educational achievement. She is currently a Specialist Epidemiologist in the Department of Medicine, University of California, San Francisco (UCSF) and is an

affiliated faculty with the UC Berkeley/UCSF joint Robert Wood Johnson Health and Society Scholars program.

Dr. Doug Jutte joined the Manitoba Centre for Health Policy as an RBC Financial Group Child Health Clinical Research Fellow in April, 2004. He is working with Drs. Roos and Brownell on his study entitled "The Apgar Score as an Early Measure of Resilience". Activities on the Apgar project to day incldue a review of the Apgar-related scientific literature, an initial survey of population Apgar score distributions, and rgression analyses and modeling for analysis.

Researcher and PhD student Randy Fransoo continues to work closely with project leaders Drs. Noralou Roos and Marni Brownell in the planning, analysis and interpretation of results using administrative education and health data related to children and youth. Fransoo has presented results of the Child Health Atlas research over 35 times (and counting), including at several national conferences – raising the profile of the work, and RBC's support. The RBC award helps support Fransoo's research on how children's health status in the pre-school years may affect their later progress and performance in school.

There were several RBC Visiting Fellows and Researchers this year. They included:

Dr. Stefania Maggi (CEEDS) visited MCHP in October 2005 and presented a noon colloquium for the department of Community Health Sciences entitled "Development and Prediction of Adolescent Smoking and Drinking" and led a two day workshop entitled "Introduction to the Analysis of Change with SAS Proj TRAJ".

Dr. Lisa Stroschein (Assistant Professor in the department of Sociology at the University of Alberta) visited MCHP in August 2005 and worked with MCHP researchers to help them understand the methods she is using and presented a lunch hour colloquium entitled "The mental health consequences of divorce: Do children and their mothers respond similarly?" Dr. Strohschein is undertaking an RBC sponsored project using Repository Data to enable MCHP researchers to understand how our unique time series data can be used for better understanding the impact of parental divorce on children.

Dr. Fiona Stanley visited in November 2005. Dr. Stanley is the founding Director of the Telethon Institute for Child Health Research established in Perth, Australia in 1990. Dr. Stanley was a keynote speaker at the Healthy Child Manitoba, Child Day Forum and, along with Noralou Roos and Marni Brownell, attended a plenary session with the Manitoba Healthy Child Committee of Cabinet. She also attended a dinner with the Manitoba Minister of Health, Tim Sale, and a meeting with the Manitoba Minister of Family Services and Housing, Christine Melnick.

## **RURAL & NORTHERN HEALTHCARE DAYS**

MCHP hosts an annual Rural and Northern Healthcare Day, designed specifically to highlight MCHP research of relevance to the rural and northern Regional Health Authorities of Manitoba. The format for the day is workshop—oriented, whereby reports are highlighted and then further explored in facilitated roundtable discussions. The 12th annual Rural and Northern Healthcare Day held on October 18, 2005 set a new record for attendance—207 registrants.

The day began with introductions by Patricia Martens and "research into action" stories from *The Need to Know* Team members Nancy McPherson (Brandon RHA), Tannis Erickson (Interlake RHA) and Sue Crockett (Nor-Man RHA). These stories relate to what RHAs do with the research that comes out of MCHP when they take it back to their regions—how the "evidence is turned into action." The stories presented served as a model for the facilitated group sessions in the morning.

Nancy highlighted the cardiac care story in their region. Diseases of the circulatory system are the number one cause of death. To begin getting at what is behind the data, the age and sex adjusted rates for hospitalizations for AMI were examined. Brandon rates were higher than the provincial rates. Cardiac catheterization and other intervention rates were lower than the provincial average. When they took this data back to the ICU staff for further clarification, it was found that indeed the rates were reflecting practice—but why? A chart audit is planned to try and answer this question.

Patricia Martens' continual challenge to members of the Team to "find the golden nuggets" was rewarded with her being presented with the first Golden Nugget Award in recognition of her work in mining the golden nuggets—finding the stories in the data that speak to action plans for the future.

Quote from evaluation form feedback:

Randy Fransoo presented the key findings from the deliverable Sex Differences in Health Status, Health Care Use, and Quality of Care: A Population-Based Analysis for Manitoba's Regional Health Authorities. Each RHA group was facilitated by a Team member and assisted by an MCHP researcher or systems analyst. They explored and discussed graphs from the report which would be particularly applicable to their region, looking for the stories in the data. Their findings were then summarized at the end of the sessions and made available for participants to review.

The afternoon began with presentations of preliminary findings on two upcoming deliverables: Application of Patient Safety Indicators in Manitoba: A First Look by Sharon Bruce, and Using Administrative Data to Develop Indicators of Quality Care in Personal Care Homes, by Malcolm Doupe.

The day ended with a panel discussion on "What is the meaning of Quality of Care and Patient Safety for rural and remote areas? What structural approaches can RHAs use?" Panelists were: Dean Sandham, the Dean of the Faculty of Medicine, University of Manitoba; Paul Thomas, Duff Roblin Professor of Government, University of Manitoba; and Roger Strasser, founding Dean, Northern Ontario School of Medicine.

## THE LUPINA FOUNDATION PROJECT

On June 13, 2005 The Lupina Foundation pledged \$625,000 to MCHP to support web-based research knowledge transfer through the Concept Dictionary. Peter Warrian, Managing Director of The Lupina Foundation was present for the announcement. Under the leadership of Leslie Roos and Lisa Lix, this funding will build on the existing web-based knowledge transfer activities of MCHP.

The Concept Dictionary, initially established in 1996, holds over 200 concepts describing how to calculate, validate, and/or define indicators and measures. These concepts are taken directly from MCHP projects and are important tools for research continuity.

With the implementation of a new international coding standard for diagnoses and procedures (ICD-10), many of the concepts will require revisiting.

The Lupina Foundation is a private, Canadian charitable foundation established in April 2000. The Foundation is committed to research and innovation related to health and society issues. They support educational charitable organizations that share their objectives to undertake public education, patient support services, and dissemination and publication of information about the delivery of healthcare.

Five ongoing challenges in knowledge management and dissemination have been identified since the project began on July 1, 2005. They are:

- ICD-10 Project: This project will review, document, and make publicly accessible state-of-the-art efforts for enabling health services research in the new ICD-10 coding environment. Workshops were held in November, conducted by CIHI and Manitoba Health at MCHP, to give an overview of ICD-10 with the associated coding standards.
- DPIN (pharmaceutical) Project: This project will develop and document key pharmaceutical coding infrastructure for use across Canada.
- Costing Project: This project will provide accessibility to the system-wide costing infrastructure to other researchers and develop the ICD-10 transition.
- Social Concepts Project: This will expand the Concept Dictionary to cover new areas of interest to researchers focusing on interdisciplinary studies of health and well-being.
- Standardization of Map Resources: This involves documenting, cleaning and creating a catalogue of existing mapping resources used at MCHP for describing and presenting geographic data.

# THE NEED TO KNOW TEAM PROJECT

The Need to Know project involves collaborative research by MCHP, the ten non-Winnipeg RHAs, and Manitoba Health. High-level planners and decision-makers from each RHA are chosen to attend these meetings. This is funded through the Canadian Institutes of Health Research (the Community Alliances for Health Research Program 2001—2006; PI P. Martens). The goals of this project are:

- a) To create new knowledge directly relevant to the rural and northern RHAs.
- b) To develop useful models for health information infrastructure, training, and interaction that will increase and improve capacity for collaborative research.
- c) To disseminate and apply health services research so as to increase the effectiveness of health services, and ultimately the health of RHA populations.

The team meets three times per year, for two days of sessions in Winnipeg. These meetings are designed to respond to the goals by including relevant activities. This year, the Team completed their third project (released November 24, 2005)—Sex Differences in Health Status, Health Care Use, Outcomes and Quality of Care: A Population-Based Study for Manitoba's Regional Health Authorities. A fourth study is underway entitled What Works? Evaluating Manitoba's Rural and Northern Regional Health Programs and Policies at the Population Level.

Patricia Martens, *The Need to Know* Team, and MCHP were honoured nationally with the awarding of the CIHR Knowledge Translation Award in the Regional Category. The awards ceremony took place in Ottawa on November 22, 2005. Attendees from the Manitoba group included Patricia Martens (director of the Team), Louis Barre (Manitoba Health), Bev Cumming (Brandon RHA) representing the rural and northern regional health authority Team members, and Sarah Bowen, the evaluation researcher with the Team. With the presentation of this award, *The Need to Know* Team project was recognized as a textbook example of KT in action. "Their working together as a team builds capacity among both academics and planners and facilitates dissemination and application of research results in the real world of decision-making," said award presenter Rémi Quirion, Scientific Director of CIHR's Institute of Neurosciences, Mental Health and Addiction.

The meetings of the Team (May 30, 2005; October 17, 2005; January 30, 2006) incorporate a variety of sessions designed to encourage two-way learning between researchers and planners/policy-makers. Some of the sessions attended by the Team members were:

From Evidence to Action—Addressing Challenges to Knowledge Translation in Manitoba. This three-year CIHR-funded research project has been developed in response to the identification of organizational barriers that hinder evidence-informed planning and decision making at the RHA-level. The project will identify, from the perspective of the RHA decision makers themselves, organizational factors that hinder evidence-based decision making in RHAs and collaboratively develop strategies to address these barriers. Some barriers that have been identified through previous consultations include: (i) time constraints/work demands that leave insufficient time for facilitating capacity building at the organizational level, (ii) crises that push research off the agenda, (iii) difficulties establishing effective communication channels within the RHA, and (iv) insufficient awareness of the importance of research and the skills required to use it effectively.

The objectives of this project are to develop, apply and collaboratively evaluate designed instruments and strategies that address barriers to the use of research in RHA planning and to produce user-friendly resources for use by all RHAs. The initial consultation phase has been completed. Preliminary review of the consultation results indicate a fair degree of similarity between regions with respect to the barriers they face in evidence-informed decision making. Initial discussions with the regions about the format of the assessment tool/strategy, indicate varying interest in self-assessment tools. Input will continue to be obtained from the RHAs as we get closer to the development of the assessment tool/strategy.

## **Harmonizing Privacy Workshop**

The Manitoba Centre for Health Policy hosted a workshop January 16 to 17, 2006 titled "Harmonizing Research & Privacy: Standards for a Collaborative Future. Creating Consensus for a Privacy Voluntary Standard for HSPR (Phase III)." Paulette Collins and Pam Slaughter (ICES) organized this workshop funded by CIHR (\$181,205). There were 55 registrants at the two-day meeting. An overview of the previous two workshops was held the first day followed by facilitated discussions. The objective was to develop a draft voluntary privacy standard for health services policy research that could be used across Canada by HSPR agencies. The report and finalized tool kit will be available this summer.

## **ICD-10-CA Training**

MCHP hosted training sessions November 22, 23, and 24, 2005, on using ICD-10-CA and CCI (new diagnosis coding and procedure coding from CIHI), and use of the DAD (Discharge Abstract Database) and the MADE (Manitoba Abstract Data Elements).

- Linda Tournay-Lewis gave an overview of ICD-10-CA and CCI along with the associated coding standards. A total of 20 people attended the workshops (6 from outside MCHP, 4 researchers/coordinators from MCHP and 10 data analysts from MCHP).
- Diane Wiebe from CIHI (Winnipeg) and Eileen Oleski from Manitoba Health provided an overview of the CIHI data abstract database elements and background on the Manitoba-specific database and elements. A total of 22 people attended this workshop (6 from outside MCHP, 4 researchers/coordinators from MCHP and 12 data analysts from MCHP).
- Diane Wiebe did an overview of CMG, DPG, RIW and complexity overlay along with the appropriate ways to use the information. There were 18 people at this workshop (2 from Manitoba Health, 5 from outside MCHP, 11 data analysts from MCHP).

## **VISITORS**

In February 2006 as part of ongoing child health research initiatives, Drs. Noralou Roos, Leslie Roos, Marni Brownell, Irene Yen and Doug Jutte gathered for collaborative meetings in San Francisco and Nicosia, California. Further research meetings and presentations also took place with Dr. Len Syme and Dr. Tom Boyce of the Department of Community Health and Human Development, School of Public Health, University of California, Berkeley. Their research project is focused on rethinking what's important regarding children's health and wellbeing and SES gradients in outcomes and resilience.

Dr. Nancy Meagher, Executive Director of UBC's Population Health and Learning Observatory visited MCHP on January 18, 2006 and gave a presentation titled UBC's Population Health and Learning Observatory: Plans and Progress.

Dr. Paul Waraich, Assistant Professor, Department of Psychiatry, UBC, presented on June 15, 2005 to MCHP researchers on the initial findings of the project Continuous Enhancement of Quality Measurement in Primary Mental Health Care. This project is aimed at fostering quality improvement in primary mental healthcare through quality measurement. A national group of clinicians, decision makers, people who use mental healthcare services, and academics will discuss and agree upon a small set of measures that can be used at the practice level across the country to foster coordinated and comprehensive quality improvement efforts.

Dr. Jin Ma, Visiting Speaker from the former Shanghai Medical University, on June 29, 2005, presented his research Health Services Research in Shanghai.


Simon Fraser University visitors Dr. Michael Hayes, Darrin Grund and Irene Rodway initiated an all-day meeting with MCHP regarding how the Centre databases our housed and administered. They are looking at building a centre at SFU that will have researchers and clinicians sharing space. They brought their two architects and spent part of the day touring Bannatyne Campus.

On August 16th RBC Visiting Scholar Dr. Lisa Strohschein, Assistant Professor, Department of Sociology, University of Alberta, presented on the *Mental Health Consequences of Divorce-Do children and their mothers respond similarly?* 

## **WEBSITE**

MCHP began monitoring website use in January 1998, using access logs from the University of Manitoba Apache WWW server. This approach permits counting the number of "hits" and unique hosts accessing and loading information from specified website locations. A hit is counted once for every time a browser goes to the server and requests a new web page. A host represents a unique internet ID, either the IP (internet protocol) number or the resolved host name.

Care is required when interpreting information generated by automated computer monitoring. Hits, for example, are counted once for each graphic file within a web page and once for every time internet crawlers or "bots" are automatically sent by search engines as they update their own sites. Graphic files have been excluded from the counts in the graph below, but internet crawlers are not always easily identified. As well, certain hosts may represent a network of firewalled users who are not distinguishable using this method (for example, one host may represent 50 different users). On the other hand, because of the Concept Dictionary use at Monash University in Australia and "mirroring" of Epidemiology Supercourse lectures in approximately 39 servers worldwide, these figures might represent an underestimate of international interest.



The graph above tracks the average number of hits and hosts per day from April 1, 2000 to March 31, 2006 for the entire website. The total average number of unique hosts accessing the MCHP website has increased dramatically since the year 2000/2001 where we saw an average of 100 unique hosts per day vs 765 in 2005/2006. MCHP maintains several web-based resources to facilitate the development and maintenance of an information-rich research environment. The Glossary, Concept Dictionary and Research Protocol are the central components of MCHP's research resources. They document key terms used in population health and health services research; record conceptual and operational definitions and SAS code for research constructs developed or tested by MCHP researchers; capture critical steps in the implementation of research plans for projects completed with Repository data.

Organizing and centralizing new knowledge so that others can use it—and then pass it on to succeeding generations of researchers—is important for ensuring the high level of research productivity and competitiveness in funding applications for which MCHP researchers are well known.

## The Glossary

The Glossary is the entry point to both the Research Protocol and Concept Dictionary. It is a compilation of short definitions of terms used in MCHP deliverables and other publications. The main focus for Glossary content is population health, health services, and research methods. Individual Glossary terms are accessible through 26 alphabetical files and one numeric file. Each term contains a brief definition and the source for that definition, which may be a Glossary-specific reference list, the Concept Dictionary, Research Protocol, or another identified source. Each term also includes links to related terms, more detailed information contained in the Concept Dictionary or Glossary, or relevant non-MCHP websites.

## The Concept Dictionary

The Concept Dictionary contains detailed operational definitions of variables or measures used in MCHP research. For example, one concept that was added this year focusses on defining the incidence and prevalence of hormone replacement therapy using administrative data. The incidence and prevalence measures are created, in part, using Anatomic Therapeutic Chemical (ATC) classification codes, which are found in the prescription drug database. The SAS code developed by an MCHP programmer to extract records with the relevant ATC codes from the prescription database, and to calculate the incidence

and prevalence measures using population counts from the provincial registry, is included in the concept. However, the SAS code is only available to researchers who have access to MCHP's internal website. The Concept Dictionary can be searched using an expanded search engine. The Research Protocol (see <a href="http://www.umanitoba.ca/centres/mchp/protocol\_external/">http://www.umanitoba.ca/centres/mchp/protocol\_external/</a>)
The Research Protocol focusses on the sequence of activities that facilitate completion of a research project using the administrative data housed in the Repository. These activities include developing the proposal, obtaining the necessary study approvals, defining the study design, and cleaning and analyzing the data. The use of a project website to communicate the research plan and analyses to research team members is also discussed. The Protocol includes a listing of the more than 60 databases housed in the Repository. Descriptions of the source and content of these databases are under development.

**The Lupina Foundation** has provided five years of funding to support the enhancement of these leading-edge research resources (Glossary, Concept Dictionary, Research Protocol). In this first year of funding, work has focussed on adding new content about the recent transition from ICD-9-CM to ICD-10-CA, to both the Glossary and Concept Dictionary; operational definitions of co-morbid (i.e., co-occurring) health conditions; and operational definitions for measures of the social determinants of health. ICD-10 is the classification system used by Manitoba to capture diagnoses in vital statistics and hospital data. The recent move to ICD-10-CA in the 2004/05 hospital data means than many MCHP concepts need to be re-defined and validated—a very large and complex task! New measures of the social determinants of health include geographic mobility and educational attainment. The support provided by The Lupina Foundation will enable MCHP to expand its documentation on healthcare costing methods and prescription drug utilization, and to facilitate national and international collaborations on these and other methodological issues.

A number of other resources that may be of interest to individuals who conduct research using administrative data are maintained on MCHP's external website (see <a href="http://www.umanitoba.ca/centres/mchp/teaching.html">http://www.umanitoba.ca/centres/mchp/teaching.html</a>). These include the outline and readings for the Department of Community Health Science's graduate course, Epidemiology of Health Care. Online tutorials for using SAS and geographic information system (GIS) software are provided. There are also links to lectures developed by MCHP researchers for the University of Pittsburgh's Epidemiology SuperCourse, an internationally-recognized teaching resource.

## **WRHA DAY**

The third annual MCHP/Winnipeg Regional Health Authority (WRHA) Workshop was held on Tuesday, December 6, 2005. This collaborative workshop between decision-makers and researchers was titled: Strengthening the Translation of Evidence into Programs/Policies (STEPs).

This workshop was jointly sponsored by MCHP, WRHA and the CIHR's Institute of Health Services and Policy Research. The workshop coordinator and MCHP researcher Malcolm Doupe, was one of five successful applicants to receive CIHR funding. There were a total of thirty that applied nationally.

In total there were 137 registrants for the day. The day began with opening remarks from Michael Moffat, WRHA's Executive Director of Research & Quality. He stressed the importance of interaction and collaboration between decision-makers and researchers. "Increasing the use of MCHP's world-class research combined with the 'first hand' knowledge of decision-makers on how systems work and why things are done the way they are, will further enable the use of research data in policy decisions."

Concurrent sessions were held throughout the day, linking WRHA decision-makers with published and ongoing research projects at MCHP, including the Mental Illness report and the Personal Care Home Quality Indicators report. At the end of the day, each group spokesperson summed up their discussions with summary action statements.

The day resulted in a wonderful opportunity to continue and strengthen our ongoing collaborative working relationship between MCHP and WRHA.


