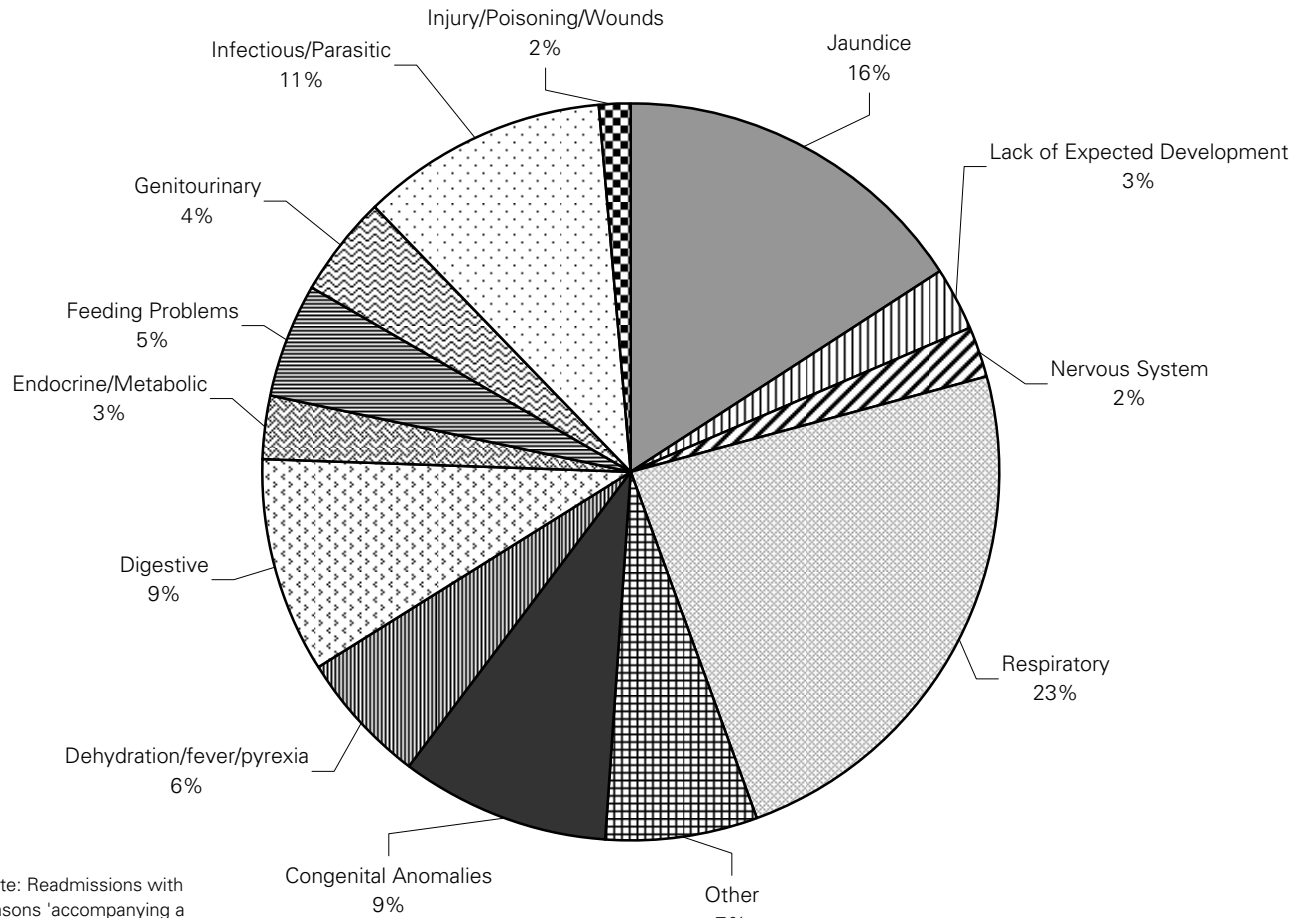


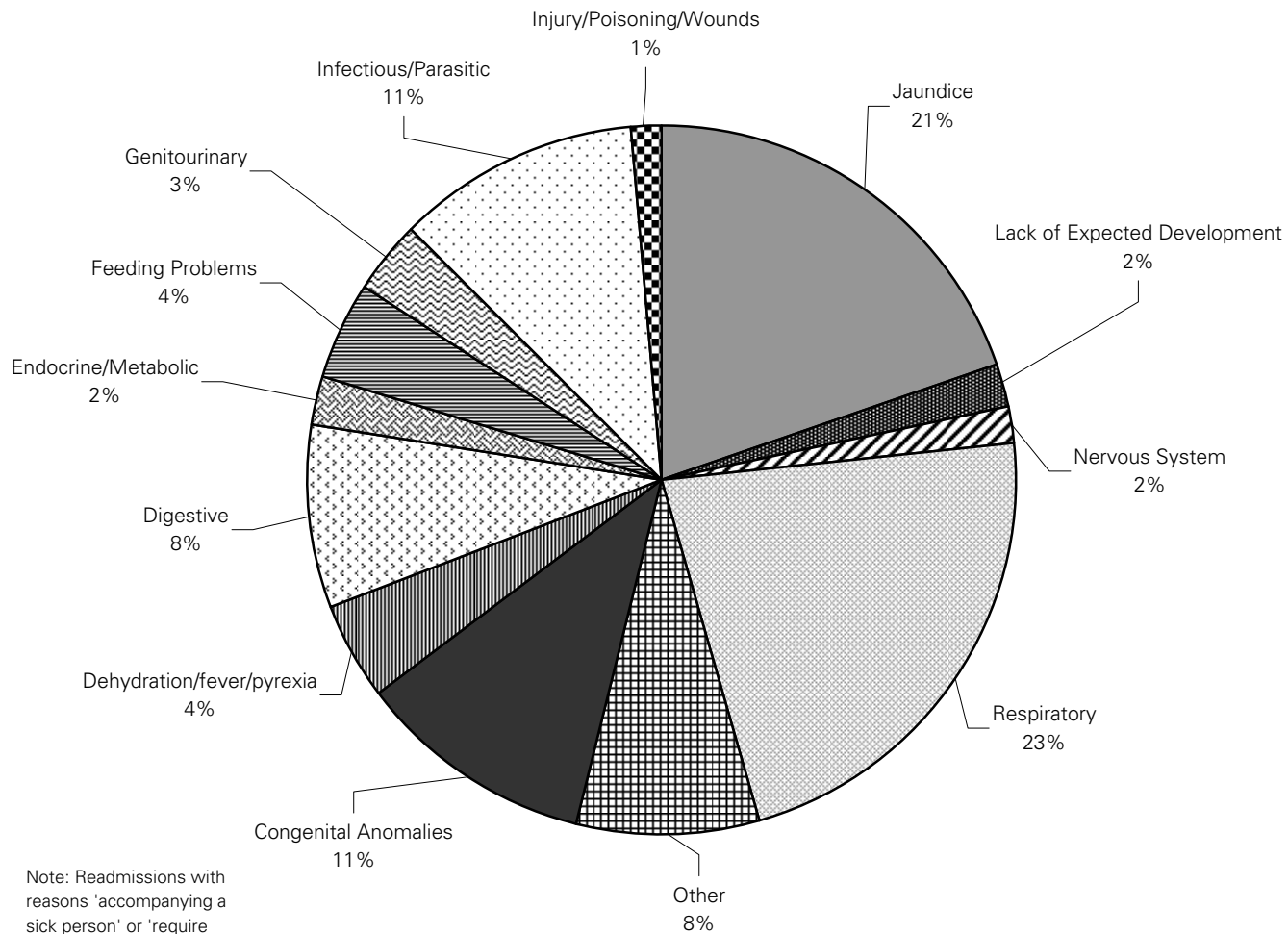
Figure 3.132: Reasons for Newborn Hospital Readmission Within 4 Weeks of Birth Discharge, Manitoba, 1996/97-1999/2000

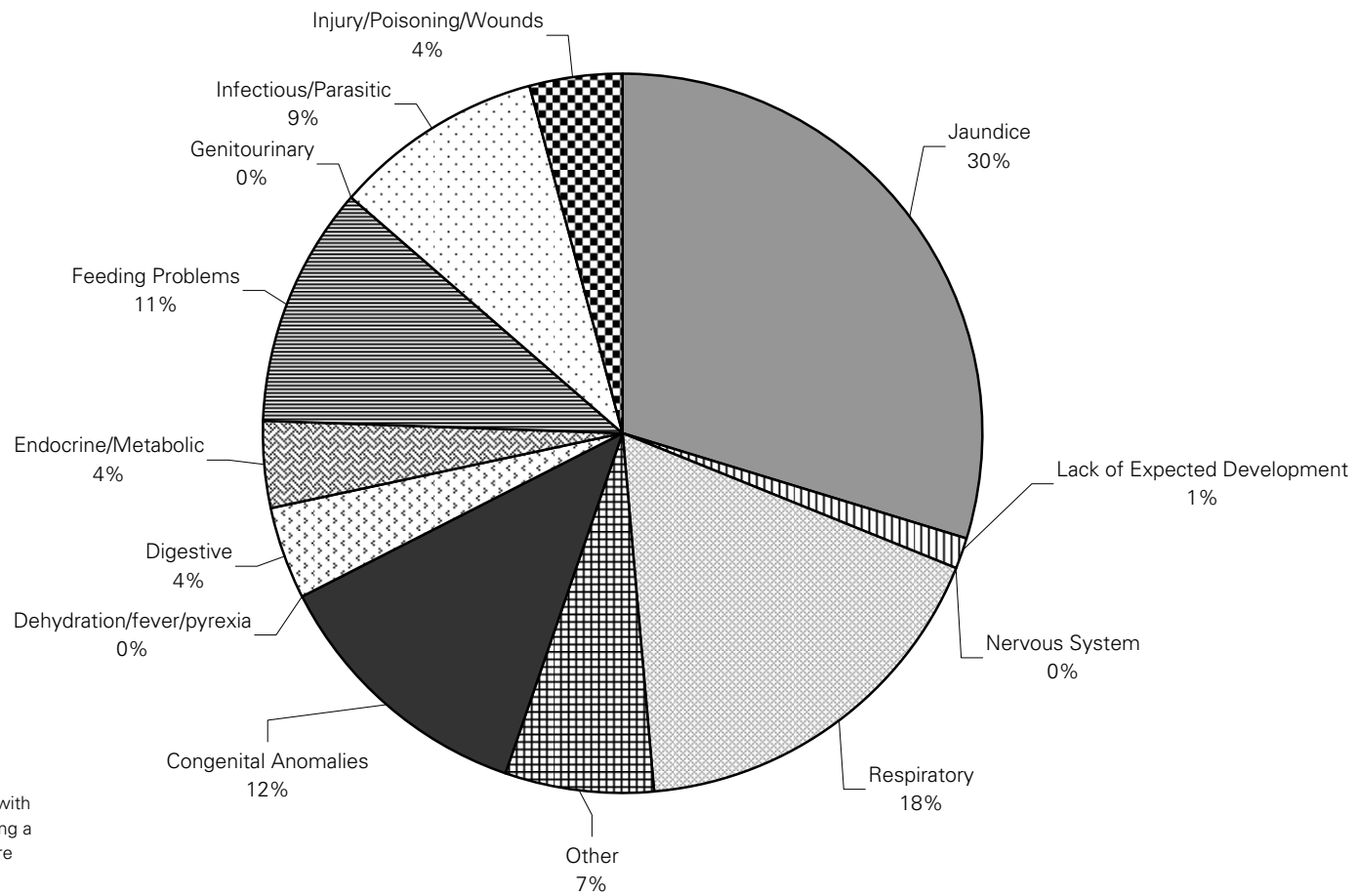

Figure 3.133: Reasons for Newborn Hospital Readmission Within 4 Weeks of Birth Discharge, Manitoba, 2001/02-2004/05



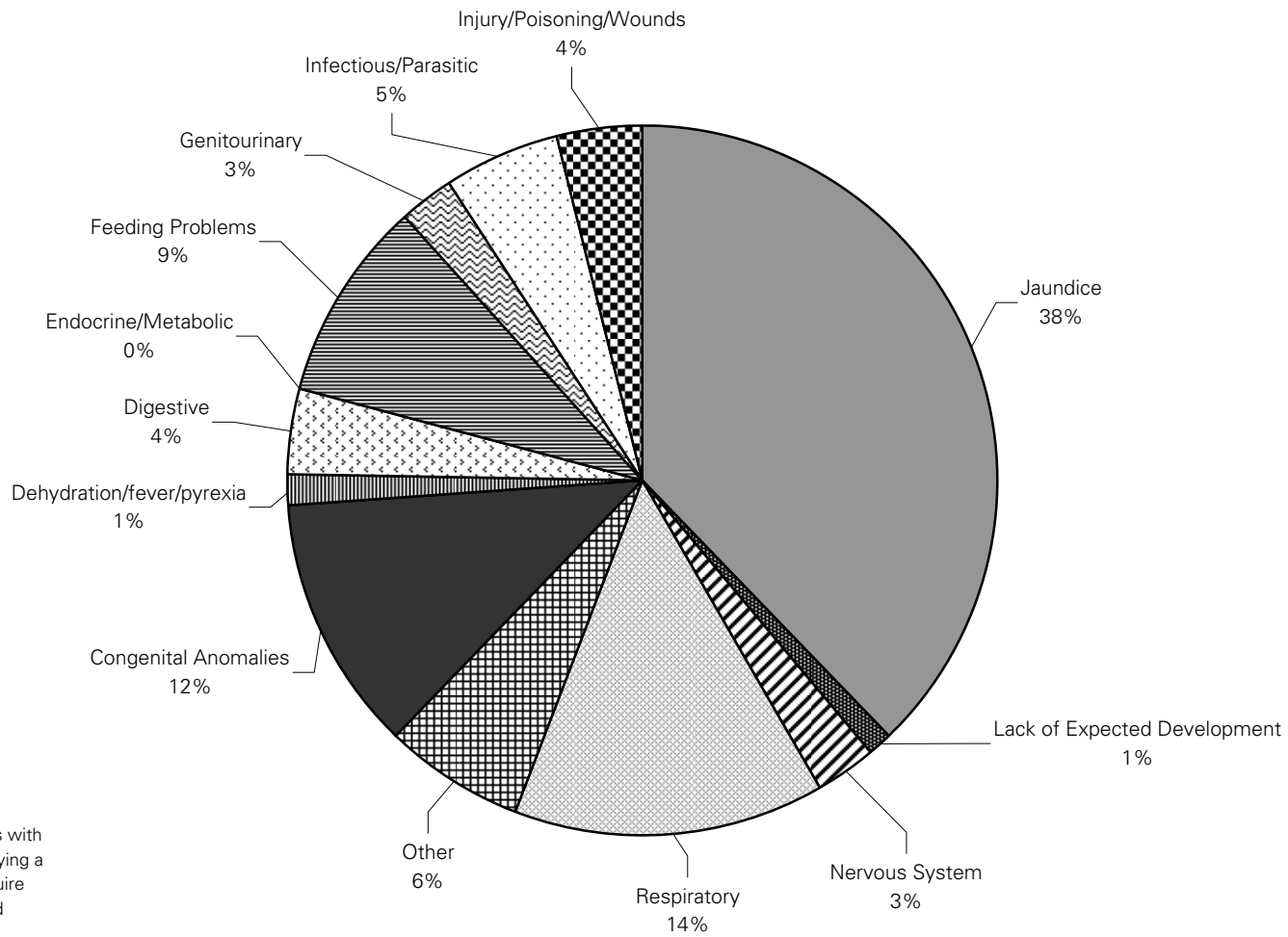

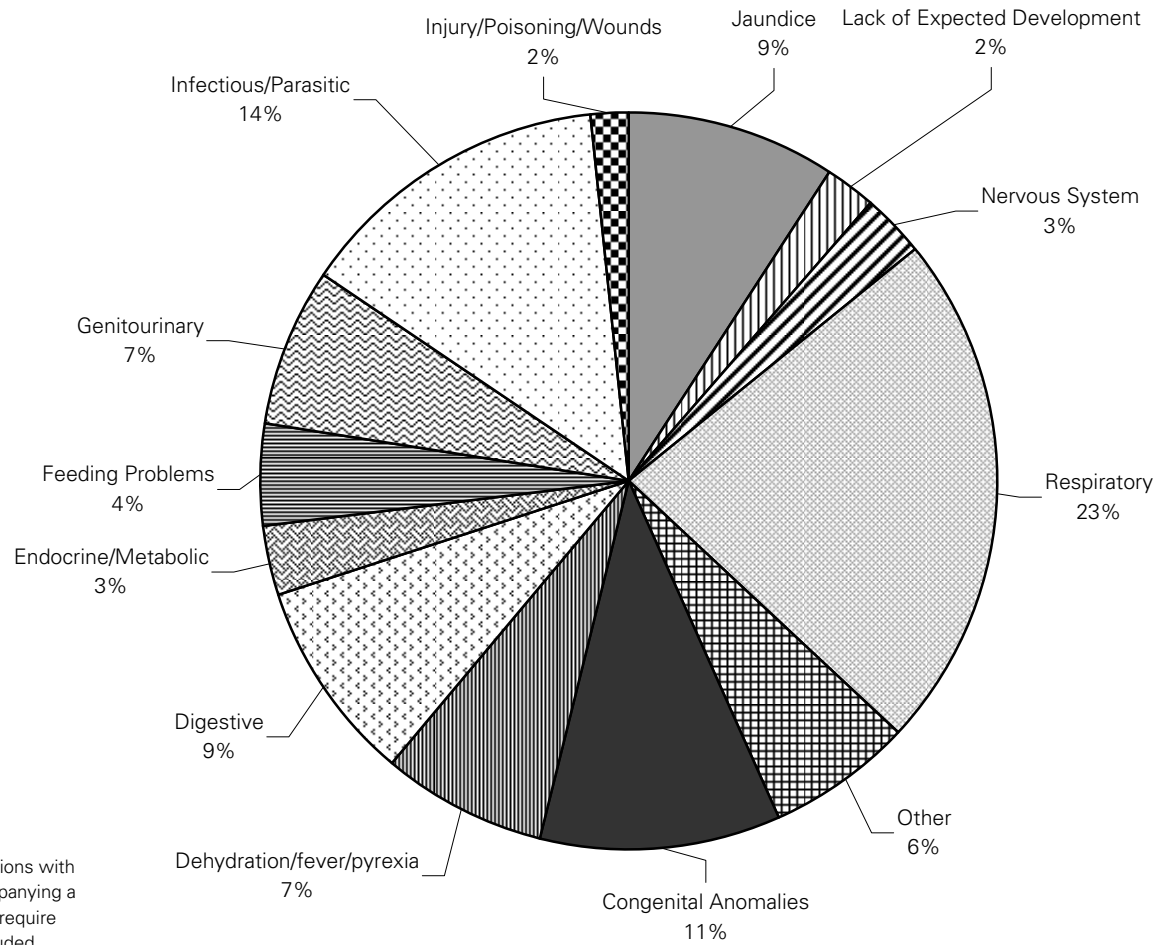

Figure A.3.123: Reasons for Newborn Hospital Readmission Within 4 Weeks of Birth Discharge, Brandon, 2001/02-2004/05



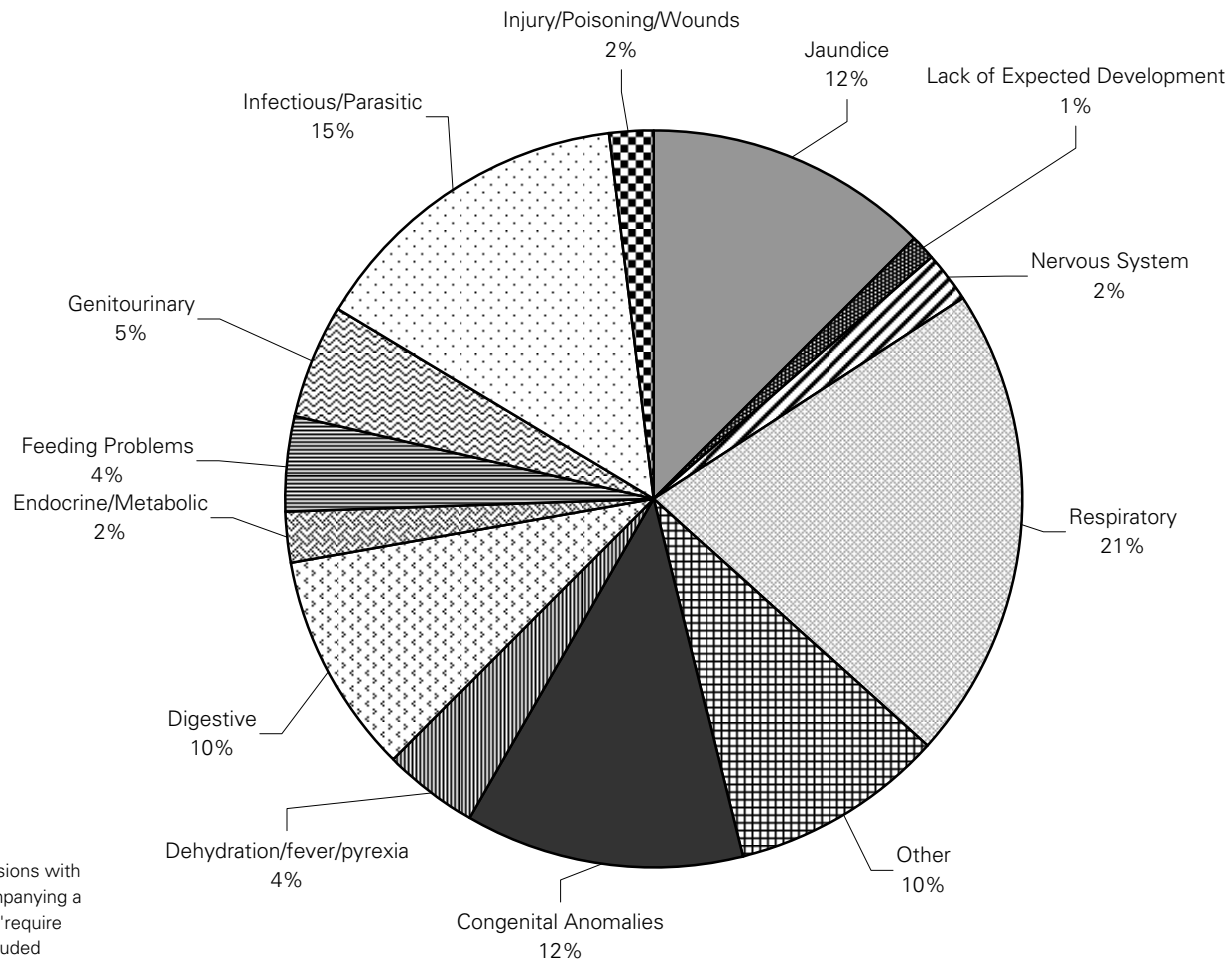

Figure A.3.126: Reasons for Newborn Hospital Readmission Within 4 Weeks of Birth Discharge, Mid, 1996/97-1999/2000

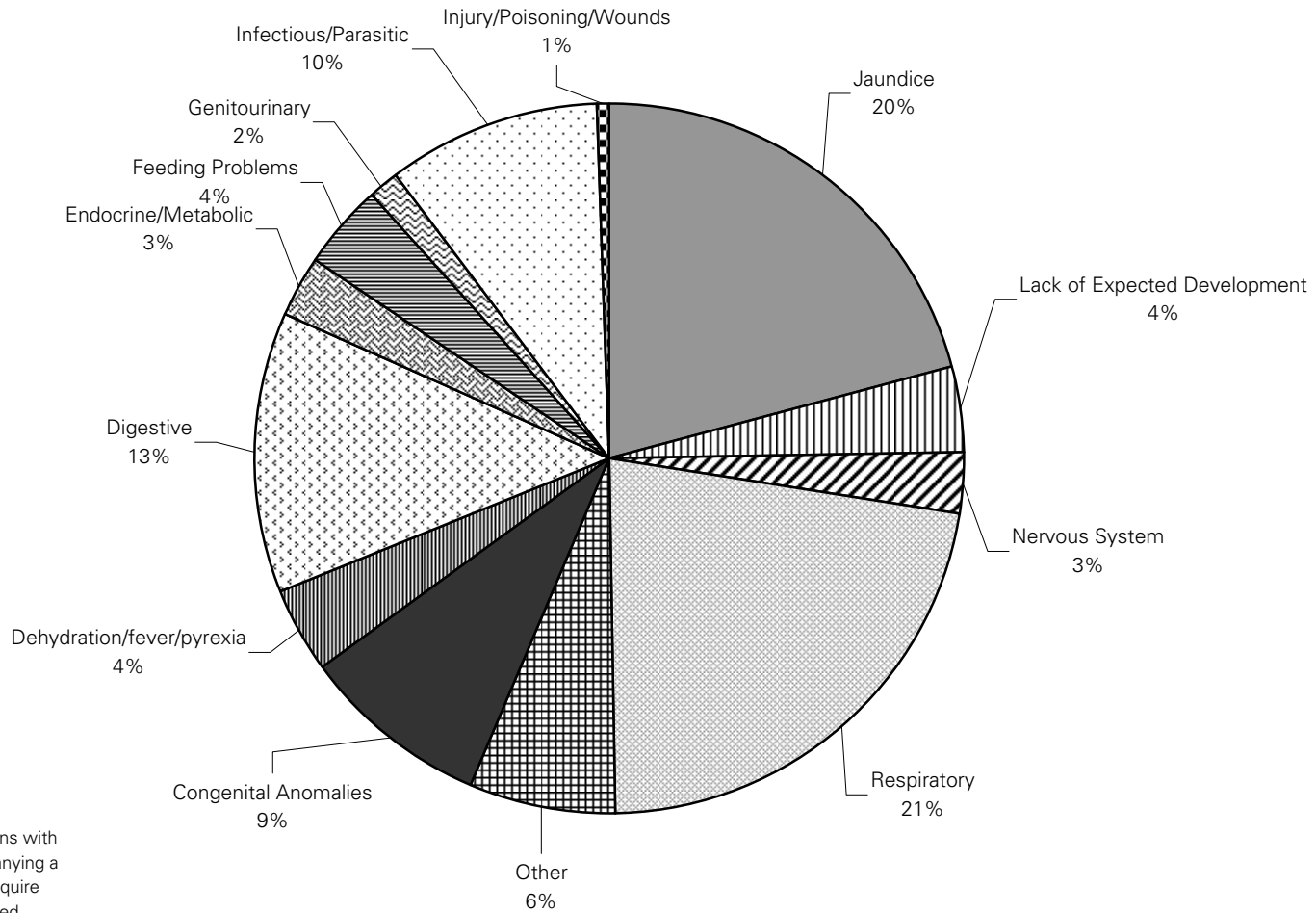
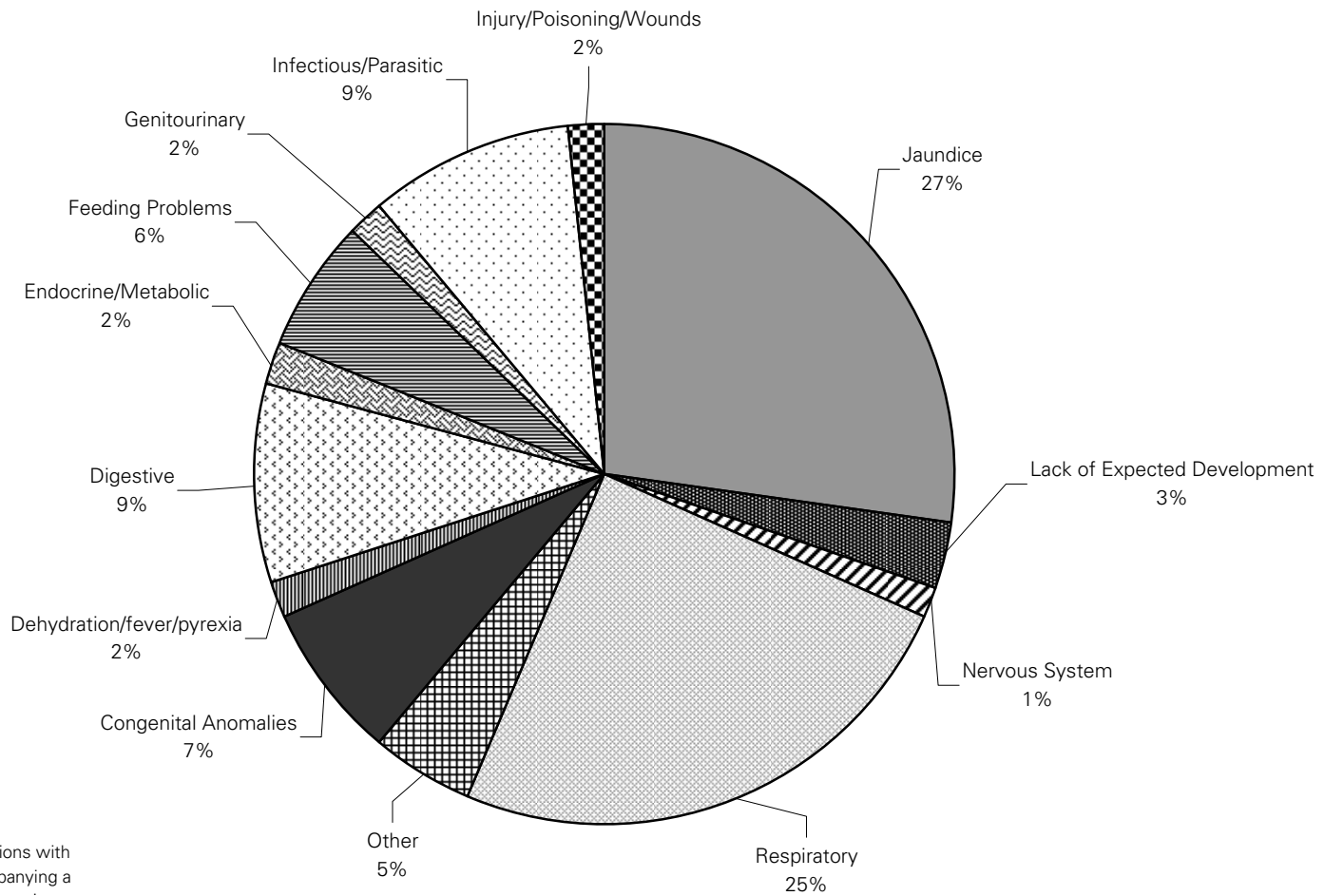
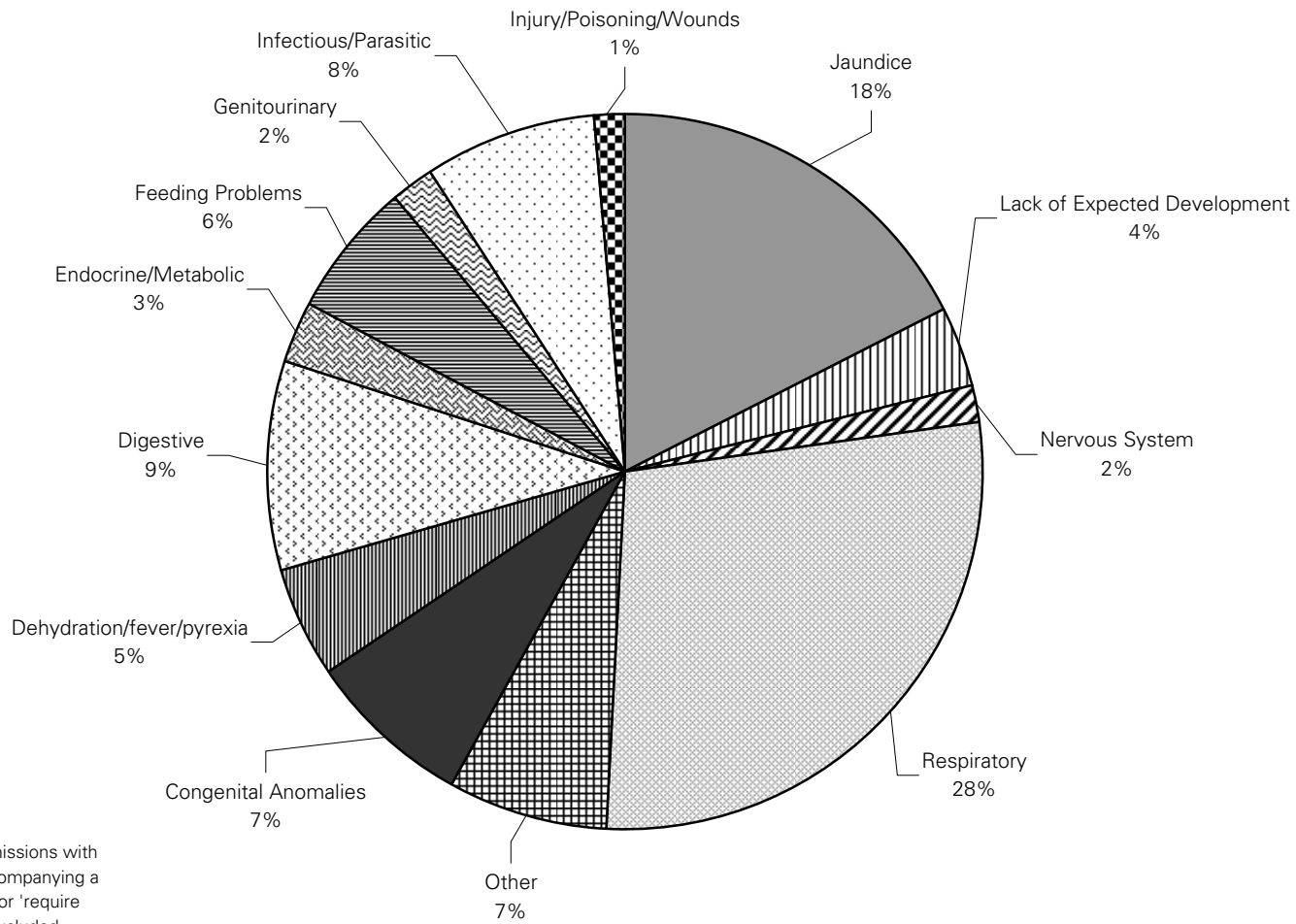


Figure A.3.127: Reasons for Newborn Hospital Readmission Within 4 Weeks of Birth Discharge, Mid, 2001/02-2004/05



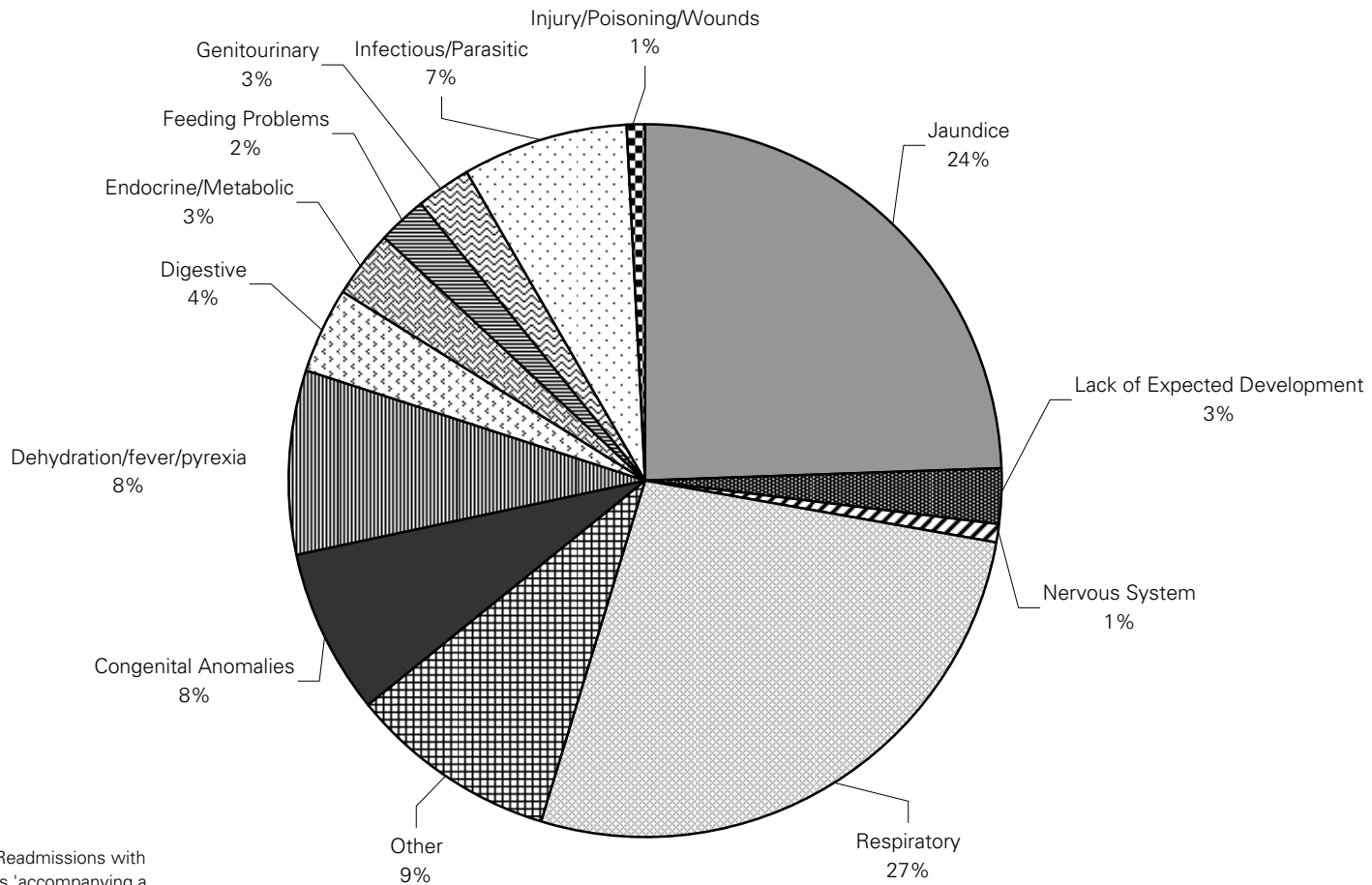

Figure A.3.130: Reasons for Newborn Hospital Readmission Within 4 Weeks of Birth Discharge, South, 1996/97-1999/2000

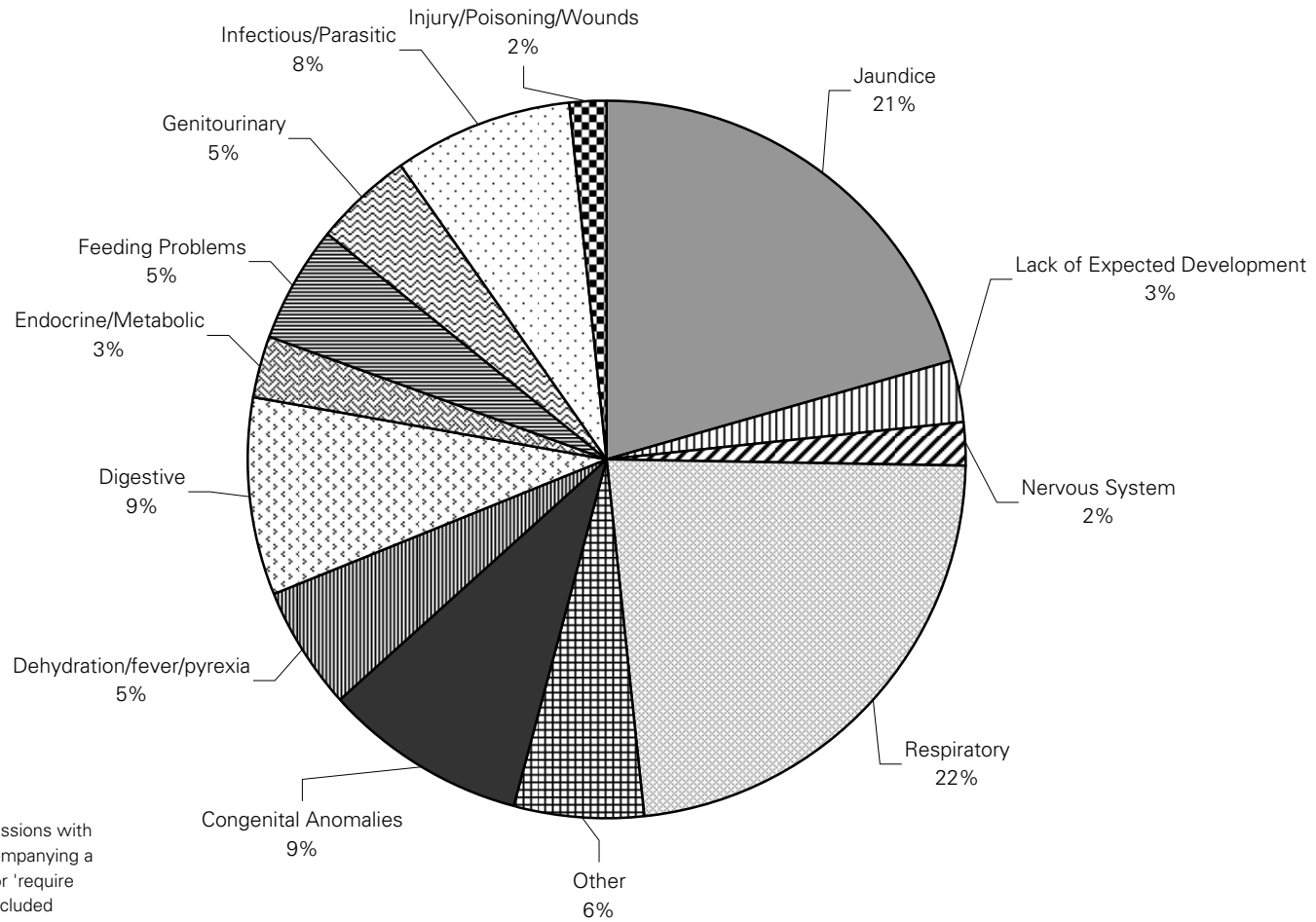
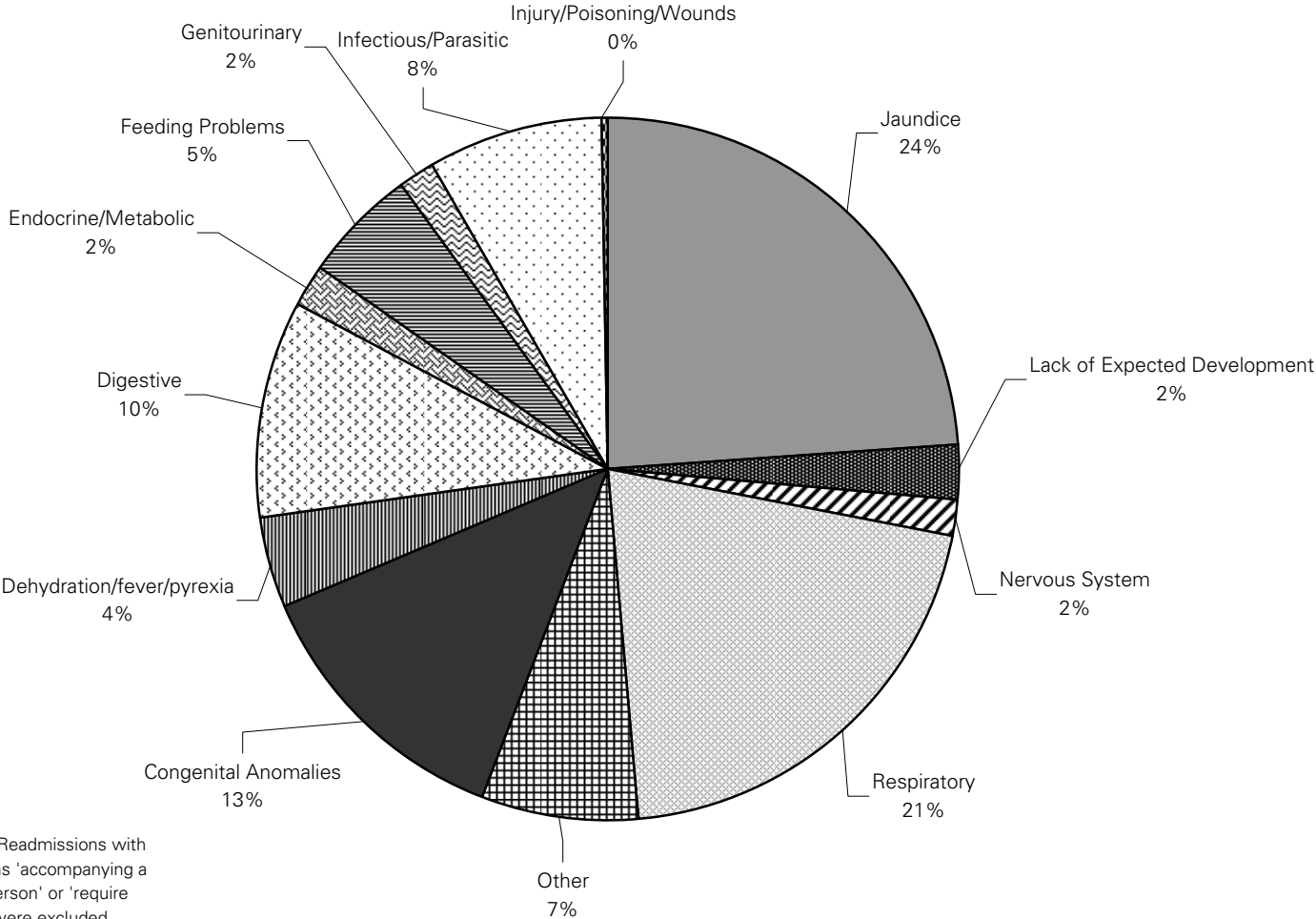


Figure A.3.131: Reasons for Newborn Hospital Readmission Within 4 Weeks of Birth Discharge, South, 2001/02-2004/05
